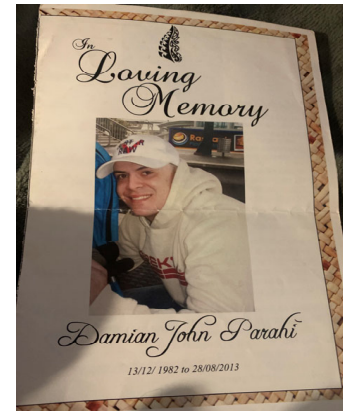


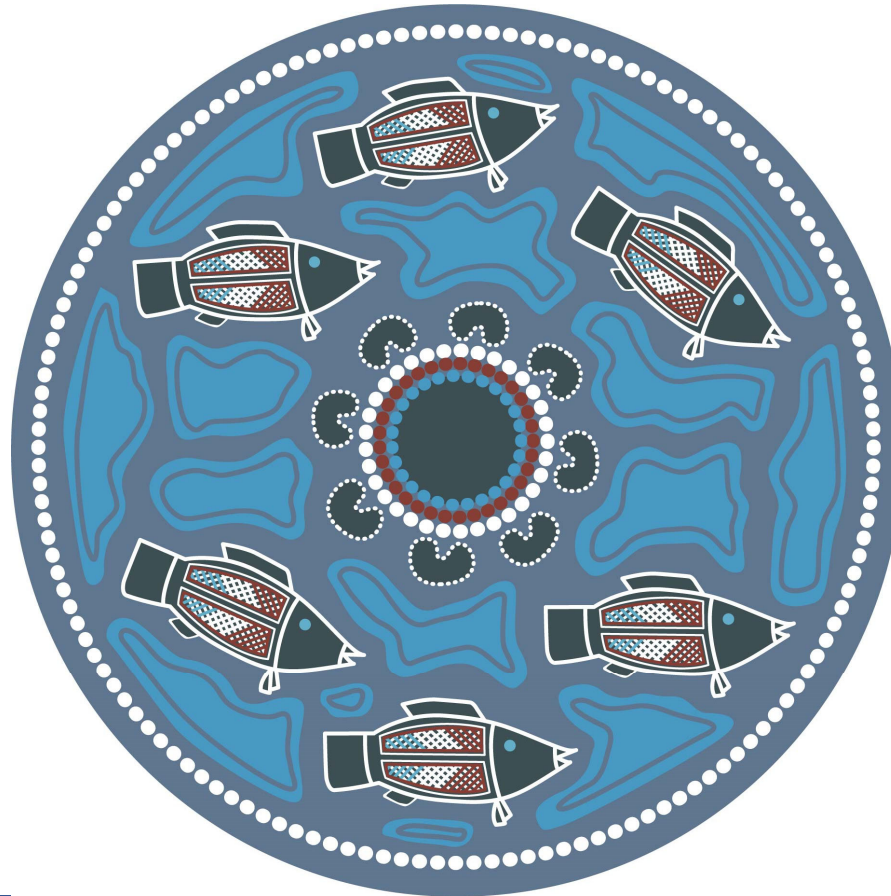

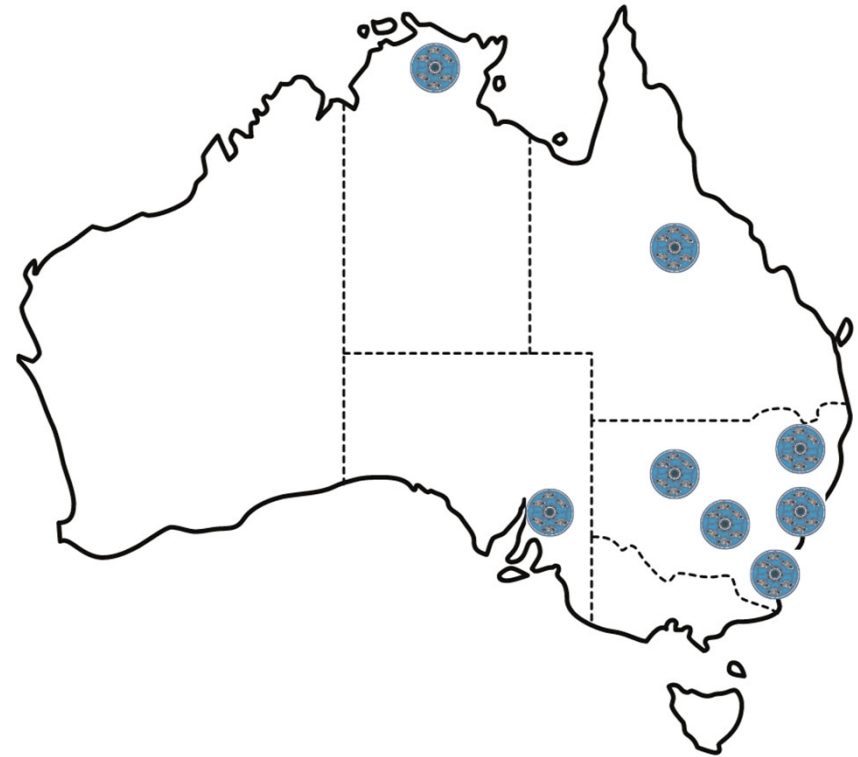


In his words *“Substance abuse has devastated my life, my family, and my community for generations. I put heart and soul into this painting because of what it represents”*.

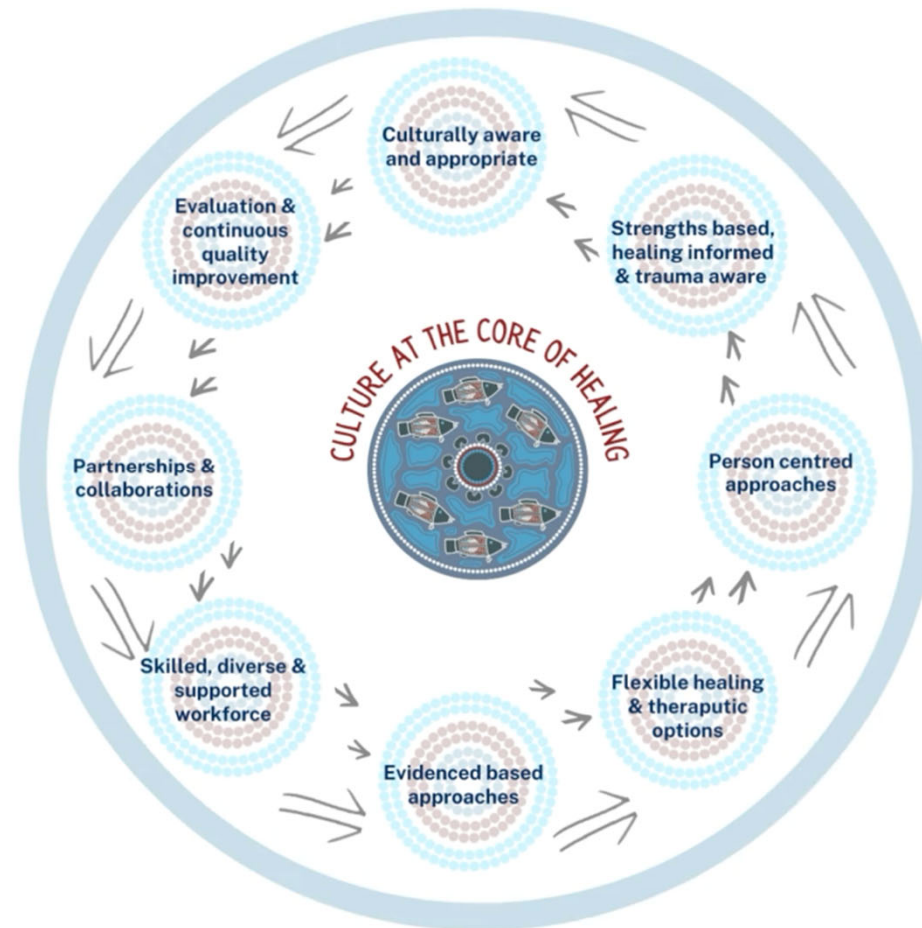

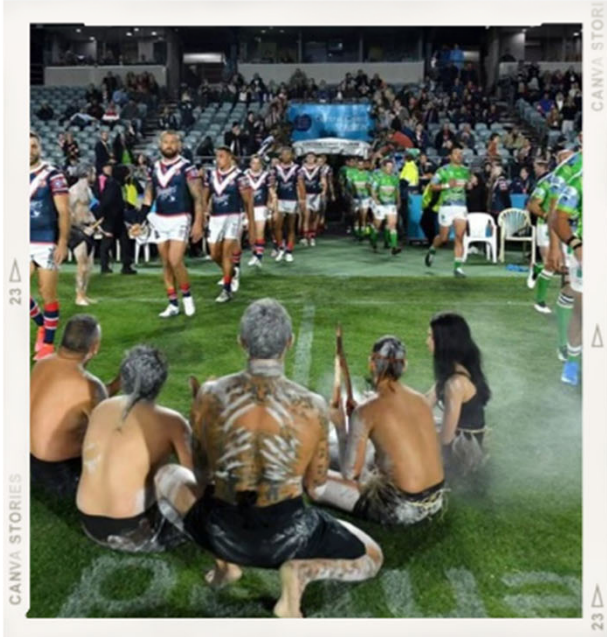


ADARRN Model of Care 2020
