Service Showcase - Goldbridge Rehabilitation Services (Queensland)

Service overview: Goldbridge Rehabilitation Services is in Southport on the Gold Coast, within the Kombumerri land, which is part of the Yugambeh language speaking nation in Queensland. Our facility is right in the heart of the CBD. Goldbridge is certified by the ATCA and was actually the first TC in Australasia to undertake and be accredited with the TC standards in 2015.

Our residents: We work with people of all genders aged 21 to 65+. Our average age is currently 42 years. Goldbridge can accommodate 28 residents in the TC and was first established in 1987. We provide a results-driven program focused on personal change, enhanced psychological well-being and social functioning.

Our staff: Goldbridge employs a multi-disciplinary team of experienced professionals, including people in the fields of psychology, social work, medicine and education, as well as Goldbridge graduates who have gone through certification in Alcohol and Other Drugs (AOD) and Mental Health (MH) work. Goldbridge aims to have 50% of the staff team as lived experience people.

Service highlights: On 26th June 2024 Goldbridge celebrated 35 years of service. We held an open day and welcomed visitors from Commonwealth Health, Queensland Health and local Government. In addition, Goldbridge met all of its deliverables of its Reflect RAP earlier this year and has started work on its next RAP, the Innovate RAP.

Member worker spotlight



Toni Eachus, Operations Manager/Deputy CEO - Goldbridge

How long have you been working with your organisation and what is your role? I started with Goldbridge in January 2007 as an AOD Worker in the TC. Later I became the TC Team Leader, then Coordinator and for the last 6 years have been the Operations Manager/Deputy CEO.

How did your career develop to bring you to your current role? Born in Manchester, in the UK I started life in the fashion industry working as a designer and pattern cutter. After having my first child I decided to re-train as a teacher with the

plan to teach fashion and design. However, these jobs are very limited, so I began working in the prison education system teaching art, literacy and numeracy. This led me to working with disengaged adults including those affected by problematic alcohol and other drug use. After moving from the UK to the Gold Coast in late 2006, I saw a small advert for an AOD Worker at Goldbridge. The selection criteria included facilitation skills so I figured with my teaching experience with marginalised people I should apply, and the rest is history.

Can you describe a typical workday for you? My role is to oversee all program areas to ensure the use of evidence-based and trauma-informed principles, whilst maintaining the TC Model. I also monitor compliance and coordinate internal and external audits to maintain accreditation.

What do you find most rewarding about your role? Seeing people come into the TC and make lifelong changes and going on to achieve a newfound sense of stability, structure, and routine, equipping them with essential tools to navigate life without substance use. In addition, being a part of the TC movement and the TC standards accreditation process. Whilst Audit are a lot of work, I really love the ATCA TC standards as they focus on the clients, the TC model and allow us to reflect on our practice to make sure we are a Therapeutic Community.

What hobbies or interests do you enjoy outside of work to help with your self-care? Outside of work I like to listen to music and enjoy going to concerts, I find music and dancing is a good way to de-stress. I also have a horse. Whilst I am not currently riding him, I do 'Natural horsemanship', which is a horse training technique, that aims to establish a deep understanding and communication between humans and horses. The term 'natural' comes from the emphasis these techniques put on working with a horse's 'natural' instincts and behaviours to develop a partnership based on mutual trust, co-operation, respect, and clear communication similar to how we work with our clients in the TC.

The 19th European Federation of Therapeutic Communities Conference was held in Poland from the 24-26th September. The theme of the conference was "Shaping the Future Together", promoting international collaboration, exchanging experiences and research to develop knowledge, understanding, and skills in the field of therapeutic communities. Over 300 people gathered for the conference from over 20 countries. On the third, last day of the conference the highlight of the event was the speech of prof. George De Leon from the USA, who is considered one of the most prominent authorities in the field of therapeutic communities, who mainly set out the vision for developing therapeutic communities in the near future. Research and reports

Inquiry into the health impacts of AOD in Australia

On 22 August, the Hon Mark Butler MP, Minister for Health and Aged Care, made a referral to the House Standing Committee on Health, Aged Care and Sport to commence an inquiry into the health impacts of AOD use in Australia. The inquiry will assess whether current services across the AOD sector are delivering equity for all Australians, value for money, and the best outcomes for individuals, their families, and society, and examine how sectors beyond health can contribute to prevention, early intervention, recovery and reduction of AOD-related harms. The ATCA is currently working on submission which we will submit to the Inquiry soon. If you have any feedback for the ATCA's submission please contact atca@atca.com.au. Buprenorphine now replaces methadone as the most common medicine for opioid dependence: 10-year trends in opioid agonist treatment medicines in Australia

National Drug & Alcohol Research Centre

In Australia, both methadone and buprenorphine have been subsidised by the Pharmaceutical Benefit Scheme (PBS) for the treatment of opioid dependence (termed 'opioid agonist treatment' or OAT) for several decades. In September 2019, a new formulation of long-acting injectable buprenorphine became available on the PBS. Administered weekly or monthly, long-acting injectable buprenorphine provides clients with an alternative option to methadone liquid or sublingual buprenorphine tablets, which are otherwise often provided to clients via daily supervised dosing at their local pharmacy or clinic. This research examined trends in opioid agonist treatment medicines over the past ten years. Raise awareness of the redress scheme

The National Redress Scheme is for people who experienced child sexual abuse when they were in an institution. Redress can include a payment, counselling, and/or a direct personal response from the institution acknowledging and apologising for what happened. Workers in the AOD sector may be the first person that clients tell about their experiences of sexual abuse; they are in a strong position to refer people to the scheme or provide basic information about what it offers.
